# MINUTES OF THE SCHOOL SAFETY AND SECURITY COMMITTEE MEETING RED OAK INDEPENDENT SCHOOL DISTRICT Tuesday, October 15, 2024

A Regular Meeting of the Red Oak ISD School Safety and Security Committee Meeting was held Tuesday, October 15, 2024, beginning at 6:00 PM at the Red Oak ISD Education Service Center, 109 West Red Oak Road, Red Oak, TX 75154.

## 1. CALL TO ORDER / ESTABLISH QUORUM

The Regular Meeting of the School Safety and Security Committee was called to order by Phillip Prasifka, ROISD Chief of Police/Emergency Management Coordinator, at 6:04 pm.

- 3. SAFETY AND SECURITY UPDATE
  Phillip Prasifka, Chief of Police, Red Oak ISD Police Department
  - A. Police Department Staffing
    - 1. Current Staffing

The ROISD Police Department is currently one short from being fully staffed.

- 11 currently fully sworn (one vacancy)
- 5 security officers
- 1 security analyst/communications
- 1 administrative assistant/communications
- 2. Responsibilities of Staff Members

It is noted that police officers will only assist with safety and security. They are not responsible for discipline or administrative duties per state law.

- B. Fall Safety Week
  - Safety week was the week of September 9, 2024. Statewide hoax resulted in one cancelled drill that was completed the next week. Door issues discovered/rectified; some live events occurred simultaneously.
- C. Intruder Detection Audits- Two to date no noted deficiencies, in window, currently through end of November
- D. Vulnerability Assessments- New state law that every district will have an assessment by TEA. It is a three-year process, and districts are randomly selected every year.
- E. SENTINEL- Website to house all safety information. Will include Threat Assessment in the future.
- F. Area First Responder Campus Tour Invitations- Monday, August 12th.
- G. Campus Activity- Increased reports concerning vapes with THC.
